In addition to the current functionality, which remains unchanged, the electronic invoicing system brings customers new technical possibilities in the form of an invoicing portal.

What does the advanced electronic invoicing system bring to the customer?
$\Rightarrow$ Secure, structured, and easy access to documents. Documents remain for the download on portal for 60 days after they are made available.
$>$ Access to the portal for up to 5 people (authorized in the attached Notice), secured by users' own passwords
> Overview of electronic invoices paired with digital delivery notes, including the possibility of sorting and filtering by product segment (cement, concrete, aggregates), by place of delivery or other criteria.
$>$ Automatic sending of e-mail notifications in case of new invoices, delivery notes or notifications for expiration of the time for downloading documents.

## What needs to be done by the customer to have access to the portal?

$\rightarrow \quad$ Fill in and sign the "Notice" (Appendix No. 1), which can be found in the appendix to this letter. The "Notice" must be signed by the members of statutory body of the company, who grant portal access to their selected employees, as it is sensitive financial information.
> To access the portal, each customer with electronic invoicing can specify a maximum of 5 authorized persons to whom the username, initial password and other important information will be sent. After receiving the password and clicking on the link, the customer can then log in and start using the portal.
$>$ If you do not yet have electronic invoicing available from us and you would be interested in this service and subsequently access to the portal, please also fill in the form "Consent to electronic invoicing" (Appendix No. 2) and send it together with "Notice" to our address.

ANNEX No 2 (to be filled in by customers who are interested in electronic invoicing) Consent to electronic invoicing

By signing this consent, the customer confirms to the supplier CRH (Slovensko) a.s. (Danucem Slovensko a.s. as of 1.10.2027) 90638 Rohožník that in accordance with § 71 par. 1 letter b) of the Act no. 222/2004 Coll. on value added tax agrees with issuing electronic invoices as well as the following conditions for sending them:
> The Supplier is entitled to make the electronic invoice available to the Customer via the Secufex invoicing portal with notifications and login data sent to the Customer's e-mail addresses specified in this consent. Invoices will be made in pdf format with an embedded $x \mathrm{ml}$ data file.
> Credibility of origin, integrity of content and legibility of the invoice is ensured not only by the control mechanisms of business processes but also by an electronic signature, which is a part of the electronic invoice.
